Call to Order, Ethics

Chairman McNeel called the meeting to order at 3:05 p.m. and welcomed everyone. Chairman McNeel requested a roll call, determined that a quorum was present, and followed with a prayer.

Chairman McNeel called the Board's attention to the **Ethics Statement** on the screen and asked if there were any conflicts. No conflicts were noted. The Ethics Statement is on electronic page 2 of today's packet.

The change orders will primarily be comprised of the data wiring mentioned at the September Board Meeting and a waterline relocation for the Creative Arts Building.

Dr. Plemmons summarized the TESA Committee meeting noting that the committee focuses on instructional programming, academics and fees. The committee has set multiple meetings to review the upcoming recommendations for the 2022-2023 Academic year.

Diversity, Equity, and Inclusion Session – Trustee McDowell summarized the Diversity, Equity, and Inclusion Session. Dr. Helen Benjamin presented the session along with a group of panelists.

My Future NC/Adult Learner Session – Trustee Schandevel summarized the My Future NC/Adult Learner Session in detail. My Future NC is supported by the MC Belk Endowment and focuses on ages 25-45.

Law/Legal Session – Chairman McNeel summarized the Law/Legal Session presented by Ashley Campbell of Campbell Shatley Law Firm. The session focused on Title IX.

The Board took a break at 4:10 p.m. The Board returned from a break at 4:15 p.m.

Facilities Assessment Review Hickory (300 Building) and Dogwood (Haywood Early College/400 Building – The Facilities Assessment Review was presented in detail by Mr. Lanning. The assessment review provided objectives, facility statistics, definitions, formulas, condition scales for the Hickory (300 building) and the Dogwood (Haywood Early College/400 building). The Board discussed at length. A tour of both facilities will be provided at 2:00 p.m. on November 2, followed by further discussion.
