Call to Order, Ethics – Chair Milner called the meeting to order at 3:05 p.m. and welcomed everyone. Chair Milner requested a roll call, determined that a quorum was present, and followed with a moment of silence.

- Informational Reports
 - New Employee Introductions Sara Phillips, Director of Human Resources, introduced new employees. The employees included John Norman, Maintenance specialist; Justin Medford - Maintenance Specialist; and Glenjie Hipps, a full-time teacher at RCAC. All provided a summary of their background.
 - New Employee Report Dr. White called the Board's attention to the New Employee Report, noting four new full-time employees and numerous part-time employees. The New Employee Report is on electronic page 15 of today's packet.
 - College Updates Dr. White summarized last month's meetings and events. She reported on the Baker Perry event in the Auditorium on October 6, The John G. Palmer Woodsmen's meet where HCC placed first in the Quiz Bowl and Second place overall; Walk-About Campus with John G. Palmer; Phi Theta Kappa Induction Ceremony where HCC inducted 20 students in the first ceremony since 2019; The Foundation hosted the Well-Tempered Wizard Concert HCC had 150+ attendees and raised \$3,480.00 for the Haywood Strong Scholarship; The Foundation held a donor cider and donut event on campus; Strategic Enrollment Management (SEM) Plan-Dr. Hines and Michelle Harris are leading a cross-departmental team to develop a plan aligned with the guidance from NCCCS; HCC received the Dogwood Grant for \$500,000 to support the addition of teachers at the RCAC; Dr. White is speaking at the upcoming Dallas Herring Lecture sponsored by the Belk Center for Community College Leadership and Research at NCSU.
