Include children who meet either of these standards, even if they do not live with the parents
- Other people if they now live with the parents and the parents provide more than half of the other people's support and will continue to do so through June 30, 2023

INDEPENDENT STUDENT should include:

- Student
- Student's spouse, if married
- Student's or spouse's children, if student or spouse will provide more than half of children's support from July 1, 2022 through June 30, 2023, even if the children do not live with the student
- Other people if they now live with the student and student or spouse provides more than half of the other people's support and will continue to do so through June 30, 2023.
